ACTIVITIES UNDER THE AIDS TO NAVIGATION FUND

Assessment Survey of the Aids to Navigation In The Straits of Malacca and Singapore

Submitted by Indonesia, Malaysia and Singapore

Introduction

- 1. The Aids to Navigation Fund (Fund) Committee Meeting between the littoral States and the contributors to the Fund held on 16 17 April 2008 in Penang, Malaysia discussed the implementation of the Aids to Navigation Fund (Fund) under the Cooperative Mechanism.
- 2. During the meeting, the littoral States presented the initial activities of the Fund where meeting agreed to conduct an assessment survey of the Aids to Navigation (AtoN) in the Straits of Malacca and Singapore (Straits) that was proposed by the littoral States.
- 3. The objective of the assessment survey of the AtoN in the Straits is to determine the status and the extent of repair and maintenance that are necessary for the aids to navigation that was identified under the Project 5 under the Cooperative Mechanism.
- 4. The Nippon Foundation agreed to contribute a sum of US\$ 1.351 million to the Fund for the Aids to Navigation Assessment Survey to be conducted within 2008.
- 5. The meeting also agreed that the Aids to Navigation Assessment Survey will be conducted with the involvement of a third party which is Malacca Strait Council (MSC) together with the littoral States.

Scope of work

- 6. The assessment survey of the AtoN in the Straits will be conducted by each individual State with the participation of appointed third party expert. An estimated time frame for the conduct of this assessment survey is six (6) months expected from June to November 2008, inclusive of the preparation of the final report.
- 7. The proposed implementation plan of the assessment survey as follows :
