OVERVIEW

- ✘ Mandate of the ANF is to receive direct financial contributions from the international maritime community for the provision and maintenance of critical aids to navigation in the Straits of Malacca and Singapore;
- ✘ Malaysia as administration for 3 years start 2018 – 2020;
- ✘ Malaysia hosted two ANF Committee meetings in 2018: -
 - ✘ 20th Meeting hosted in 3 – 4 May 2018 at Penang;
 - ✘ 21st Meeting hosted in 20 – 21 September 2018 at Malacca;

ADMINISTRATION & OPERATION OF THE ANF

- ✘ As at 31st August 2018, the balance in ANF bank account was **USD7,002,738.19**;
- ✘ Contribution for 2018 is **USD322,737** and total contribution of approximately **USD23.2** million received since the ANF's inception;
- ✘ Contributions from China, India, Japan, Republic of Korea, United Arab Emirates, Saudi Arabia, International Foundation for Aids to Navigation, International Maritime Organization, Malacca Strait Council, The Nippon Foundation and Witherby Publishing Group

ANF WORK PROGRAM IN 2018

- ✘ Good progress on the maintenance and repair of critical aids to navigation in the SOMS as per the 10-year Plan Maintenance Programme;
- ✘ Work performance audit conducted by the Malacca Strait Council for the critical aids to navigation in the SOMS;
- ✘ Technical workshops and preliminary survey works conducted by Japan;
- ✘ New 5 Years PMP was approved: -
 - ✘ Total budget for 5 years PMP of littoral States **USD 19,530,728** which **USD 9,911,058** from total budget will be funded by ANF

2019 PLAN

- ✘ Total budget for 2019 is **USD3,400,967** of which **USD2,842,500** will be disbursed from the ANF: -
 - ✘ Littoral States' aids to navigation maintenance and repair works;
 - ✘ Work performance audit conducted by the Malacca Strait Council (MSC);
 - ✘ Administration expenditures for secretariat;

CONCLUSION

- ✘ Sustainable means to finance the maintenance of aids to navigation in the SOMS, which includes also on the capacity-building and development for technical personnel involved in the provision and maintenance of aids to navigation;
- ✘ An important platform for collaboration between the littoral States and interested stakeholders on matters relating to the aids to navigation infrastructure in the SOMS;
