OVERVIEW

- Rules of Procedures of Aids to Navigation Fund. The administration and operation of the Fund shall be undertaken by an official agent appointed by the littoral States, as the case may be, on a rotational basis in the alphabetical order, for 3 years each.
- Indonesia will be the Chairmanship of ANF for period 2022-2024
- Indonesia hosted the 26th ANF Committee Meeting 2022 in Bali









ADMINISTRATION AND OPERATION OF THE ANF

- As at 31st May 2022. the balance in ANF Bank account was USD 6,346,300.84.
- Contribution 1 September 2021 until 31 May 2022 is USD 530,000.

WORK PROGRAMME OF THE ANF IN 2021

- Total cost for AtoN maintenance and administration USD 1,013,824.
- Work performance audit conducted by Malacca Strait Council for the critical AtoN in the SOMS
- Technical workshop conducted virtually by Japan and Malaysia (8 16 February 2022). 15 participants from 3 littoral States.









PLANS FOR 2022

- Total budget for 2022 is USD 1,689,991 of which USD 1,454,991 will be disbursed from ANF
 - 1. Littoral States' aids to navigation maintenance and repair works
 - 2. Work performance audit conducted by Malacca Strait Council
 - 3. Administration expenses for secretariat
