5TH PROJECT CO-ORDINATION COMMITTEE MEETING UNDER THE CO-OPERATIVE MECHANISM ON SAFETY OF NAVIGATION AND ENVIRONMENTAL PROTECTION IN THE STRAITS OF MALACCA AND SINGAPORE

GRAND COPTHORNE WATERFRONT HOTEL, SINGAPORE 28 SEPTEMBER 2012

REPORT OF THE MEETING

1 OPENING OF THE MEETING

- 1.1 The 5th Project Co-ordination Committee Meeting on Safety of Navigation in the Straits of Malacca and Singapore was held on 28 September 2012 at the Grand Copthorne Waterfront Hotel, Singapore.
- The Meeting was attended by representatives from the three littoral States (Indonesia, Malaysia and Singapore), and observers from Australia, China, Hong Kong SAR, Germany, India, Japan, Republic of Korea, BIMCO, ICS, IMO, INTERTANKO, MSC, and The Nippon Foundation. The list of participants is at **Annex A**.
- 1.3 The Chairman, Capt M Segar, Assistant Chief Executive (Operations), Maritime and Port Authority of Singapore, expressed his appreciation and thanked the delegations from Indonesia and Malaysia, as well as all other participants for attending the Meeting. The Chairman noted that the strong support by the participants was demonstrative of the spirit of cooperation towards enhancing navigational safety and environmental protection in the Straits of Malacca and Singapore (SOMS).
- 1.4 Indonesia and Malaysia thanked Singapore for hosting the 5th Project Coordination Committee Meeting, and thanked the other participants for their attendance at the Meeting. They wished the participants positive and fruitful discussions ahead.

2 ADOPTION OF THE AGENDA

- 2.1 The Meeting agreed to Singapore's suggestion to discuss implementation issues pertaining to the Straits Projects during the status updates on these projects. The Meeting further agreed that there was no need to break into Technical Working Groups since the various projects had already been discussed at the 5th Co-operation Forum and 37th Tripartite Technical Experts Group Meeting.
- 2.2 The Meeting further agreed to Malaysia's suggestion for Straits Project 7 to be reflected as "Feasibility Study on Emergency Towing Vessel (ETV) Service in SOMS".
- 2.3 The Meeting noted that there was no need for status updates on Straits Project 4 on "Setting up a Tide, Current and Wind Measurement System for

the Traffic Separation Scheme in SOMS to Enhance Navigation Safety and Marine Environmental Protection" and the project on "Review and Enhancement of Measures Implemented in SOMS – Analysis of Marine Casualties", as they had already been completed.

2.4 The Meeting considered and adopted the agenda set out at **Annex B**.

3 STATUS REPORTS ON STRAITS PROJECTS

- 3.1 <u>Project 1 on "Removal of Wrecks in the Traffic Separation Scheme in the SOMS"</u>
- 3.1.1 The Meeting noted the updates by Malaysia. The Meeting also noted the presentation by Germany on the German Under Water Obstacle Information System (GUWIS), its wreck monitoring database.
- 3.1.2 The IMO updated that it was working together with Germany and Malaysia on Project 1, which would be funded by the 20,000 EUR contribution that Germany had pledged to the IMO Malacca and Singapore Straits Trust Fund.
- 3.2 <u>Project 2 on "Cooperation and Capacity Building on Hazardous and Noxious Substance (HNS) Incidents Preparedness and Response in SOMS"</u>
- 3.2.1 The Meeting noted the updates by Malaysia on Project 2.
- 3.2.2 The Meeting noted that Malaysia would seek technical assistance directly from Asia Pacific Applied Science Associates (APASA) to configure the data it had collected into the appropriate format for the MALACCA HAZMAT.
- 3.2.3 The three littoral States agreed that they would work out their individual standard operating procedures (SOP) for HNS incidents response before developing a joint SOP for the SOMS.
- 3.2.4 The three littoral States agreed that the real-time information from the MEH Data Centre could be integrated into the MALACCA HAZMAT.
- 3.3 <u>Project 5 on "Replacement and Maintenance of Aids to Navigation in SOMS"</u> and Project 6 on "Replacement of Aids to Navigation Damaged by the <u>Tsunami Incident of 2004"</u>
- 3.3.1 The Meeting noted the updates by Indonesia on Projects 5 and 6. The Meeting noted that Japan would be conducting a second Aids to Navigation technical workshop in 1Q 2013.
- 3.3.2 The Meeting noted that there was a need to conduct an assessment of the risks posed to aids to navigation by unidentified vessels, and to develop measures to prevent vandalism of aids to navigation. Malaysia invited the user States and stakeholders to propose ways to address these issues.

These issues could be further explored, and Malaysia agreed to present a concept paper at the 6th Project Co-ordination Committee Meeting in 2013.

- 3.4 <u>Project 7 on "Feasibility Study on Emergency Towing Vessel (ETV) Service in SOMS"</u>
- 3.4.1 Singapore updated that the three littoral States had agreed at the 37th TTEG Meeting to establish a correspondence group to examine the legal and liability regimes, and regulatory frameworks of the littoral States before working out the details of the ETV proposal. The correspondence group would submit its report at the 38th TTEG Meeting in 2013.
- 3.5 <u>Project 8 on "Concept Study on Real-time Monitoring of Under-Keel</u> Clearance in the SOMS"
- 3.5.1 The Meeting agreed to the proposed timeline presented by Singapore for the concept study as attached as **Annex C**. The Meeting agreed for Singapore to work with the focal points of the two other littoral States and the IMO to finalise the technical specifications. The focal points were as follows:
